Information on personal data protection

- The above personal data will be processed by the Data Controller for 5 years (until the end of the calendar year) following the project for accounting and control purposes. This constitutes the Data Controller's legitimate interest (Article 6(1)(f) GDPR).
- Consent to the dissemination of an individual's personal image constitutes the legal base (Article 6(1)(a) GDPR) for the use of photographic and video content for documentary, information and promotional purposes, with no restrictions as to time or territory. Consent shall be valid until the moment of its withdrawal.
- You are entitled to the following rights: access to your data, the correction, transfer and deletion thereof, the limitation of their processing, and the right to object to their processing. To exercise these rights, you must inform the Data Controller accordingly by sending an e-mail to the address indicated at the beginning of this form. You are also entitled to file a complaint with the supervisory authority if you believe that the processing of the aforementioned personal data is in violation of the applicable regulations.
- Personal data will not be processed by fully automated means and will not be profiled.
